



Cordish Dixon Private Equity Fund IV (Fund) NTA & Fund Update – 28 February 2020

NTA update

Partly paid units (each a Unit) in the Fund were issued at \$1.60. As at 28 February 2020, the Responsible Entity has called \$0.96 (or 60.0%) of the issue price.

The estimated unaudited net tangible asset value after tax as at 28 February 2020 was \$1.03^{1,2} per unit (31 January 2020 was \$1.012 per unit).

Fund update

Capital called

At 28 February 2020, the LP has called US\$65.6 million (or 50.4% of capital committed). The Fund's proportionate share is approximately US\$57.9 million (an 88.4% share).
